THE EARLY YEARS PREMIUM

Nurseries, schools, child-minders and other childcare providers are able to claim extra funding from the Government. This funding is known as Early Years Pupil Premium and is used to support children's development, learning and care.

The Early Years Pupil Premium provides extra funding per hour for three and four year old children whose parents are in receipt of certain benefits or who were formerly in local authority care but who left care because they were adopted or were subject to a special guardianship or child arrangements order. This can mean more than £300 year extra for each child taking up the full 570 hours funded entitlement to early education. This additional money could make a significant difference to us and to your child.

It is therefore important that you complete the enclosed forms so that we as a provider can claim the extra funding. Ideally the completed forms can be returned to school (Lynne Halliday, School Business Manager) or if you prefer, to the Sandhill Centre (address on form).

We will use the extra funding to build on and further improve the quality of the early years education that we provide for your child. This could include, for example, additional training for our staff on early language, providing additional resources or learning experiences, investing in training for our staff to further our expertise in areas of learning, the curriculum or areas of development such as speech and language.

Therefore we ask that ALL PARENTS/GUARDIANS OF OUR NURSERY CHILDREN complete the attached form. This will allow us to claim the additional Early Years Pupil Premium.
